Test conditions for overall migration was 15 min at 50 °C

Food simulants used for overall migration were 50 % ethanol (simulant D1), 3 % acetic acid (simulant B) and olive oil (simulant D2).

The test made on olive oil for 15 minutes at 50 $^{\circ}\text{C}$ does not comply with the requirements in (EU) 10/2011
